I. NAME OF THE TRUST

II. REGISTERED OFFICE

- (a) The Registered Office of the Trust shall be located at present at **Door No.99, Miranda Line, Kamarajar 1st Street, Theni, Theni District** or any other places as may be decided by the Board of Trustees from time to time.
- (b) The Trust may open additional Offices or Branches at any place or places it may think for the operation of the Trust, HOWEVER, all additional Offices / Branches that may be opened from time to time shall function only as the Branch Offices of the Trust.

III. OBJECTS OF THE TRUST

The Trust may own, operate or assist the following :

- (1) To Establish, Run and Manage and Construct CHURCHES and Prayer Groups.
- (2) To Establish Bible Colleges and Extension of Bible Training Centres and Arts Colleges.
- (3) To Preach the teachings of the Holy Bible through all kinds of Media and to preach through Cottage Assemblies, Public Meetings and Conventions.
- (4) To organize Church Growth Seminars, Family Conferences, Pastors Fellowships and Prayer Cell.
- (5) To organize Television Programme and Mobile Gospel Team.
- (6) To organize all kinds of Ministry Works as per the dialogue of our Christian era.
- (7) To authorized to issue the certificates of Baptism, Marriage, Burial, Dedication, Born After & Before and Ordination.
- (8) To establish, Run and Manage Homes for the Orphan Children, Unwelled Mothers, Poor, Aged, Destitute, abandoned, Street Children, Handicapped, Mentally Retarded and Etc., and to make them self reliant.
- (9) To establish Day Care Centres, Tuition Centres and Etc.
- (10) To give Primary Education to Higher Education and computer Education without any restriction as to Caste, Creed, community Race or Religion.
- (11) To help or financially assist the deserving children in their education through sponsorship programs.

- (12) To provide assistance towards schemes and vocational training program to help the education programs etc.
- (13) To establish all kinds of occupational training centres and self employment training centres.
- (14) To impart vocational and technical training to deserving children and youth.
- (15) To provide assistance towards schemes connected with self employment, training, social educational programs etc.
- (16) To organize programs to generate employment opportunities for the weaker sections and empower the vulnerable women folk.
- (17) To contribute to any other existing welfare instructions for such purpose or purposes as the Trustees may deem fit without any restrictions as to any caste community or creed, granting scholarship and subsidies to the poor students or to take over institutions with similar objects.
- (18) To start institutions promoting Social Education, Skill Development, Training and Research to uplift the poor.
- (19) To afford Medical Relief to the Sick and the Suffering without any restriction as to Caste, Creed, Community Race or Religion by constructing or maintaining hospitals, dispensaries, Maternity and etc.
- (20) To undertake Social Service activities and to provide facilities for the welfare of the poor, irrespective of caste, creed and social status.
- (21) To create all kinds of Awareness among the Society through all kinds of Media and Public Meetings.
- (22) To provide Medical Assistance and comprehensive Health Care to the deserving including awareness on AIDS, care and treatment of the HIV affected persons.
- (23) To organize and conduct programmes to give Environmental Awareness to the society and to conduct extensive research on environment.
- (24) To authorized to appoint Administrative Committee Members for Trust Promotional activities.
